filing. In response to the Federal Election Commission?s request for clarifying the circumstances surrounding the same, the following explanation is provided. The Treasurer was unaware that these receipts were initially received before the end of the quarter as they were in control of the Campaign Committee. The Committee?s campaign staff is located in New Jersey while the Treasurer is located in Washington, DC. Accordingly, these receipts were not entered as 2Q receipts into the software, rather they were entered as 3Q receipts since the Treasurer became aware of them in 3Q. However, upon learning from the candidate and campaign manager that, in fact, these were initially received by the Committee before the end of 2Q, and after consulting counsel to confirm the propriety of amending both the July Quarterly filing and the relevant 48-Hour Report, the filings were promptly amended to accurately reflect the 2Q receipt date. Again, these corrections were self-initiated by the Committee in the interests of accuracy and transparency.
